The Research Club was established in the academic year 2010-'11 in Manikchand Pahade Law College with an object of sharpening the Research skills. The club was later named as Avishkar Research club in the year 2014. Since last 12 years through this club research orientation and training is provided to member students. Further various activities are conducted such as Movie show and Panel Discussions, Poster making, Compilation of newspaper clippings in the library, Sensitisation Programmes, Seminar, Workshops, and competitions such as Research Article Writing Competitions. Each year around 200 students get registered for this club.

Earlier in the year 2013 the founder and coordinator of the Research Club Dr. Aparna Kottapalle had completed Research project funded by IIPA, New Delhi on '*The Working of consumer forums in Maharashtra -pendency disposal of complaints and remedial measures and consumer awareness in Maharashtra*' with the help of 65 Research club member students. During the year 2017-'18 the students of Research club assisted in data collection for the project titled '*An empirical study to examine the impact of legal aid services provided by the legal aid counsels on the quality of legal aid system in India*' conducted by NLU, Delhi sponsored by ICSSR. Recently in the year **2021 –'2022** Research club students assisted Aurangabad Municipal Corporation in conducting interviews of Street vendors. Thus, since beginning till now the Research club student members are engaged in providing assistance in research projects.

The Students are encouraged and trained for participating in **University and State level Avishkar Completion and Anveshan Competitions** through the Research Club. Since last 12 years many students have participated in this competition. Each year students are given training on writing of research articles, and now many of our college students have online and offline publications to their credit.

Each year Human rights day is celebrated by the Avishkar Research club by organising Regional, State and National Level Seminar Workshops, Conferences and sensitisation

programmes. Till now such programmes are organised on various themes of Human rights such as Role of Advocates, Police, Judiciary in protecting Human Rights, Right to livelihood, Right to water, Farmer's suicide, Right to shelter etc
