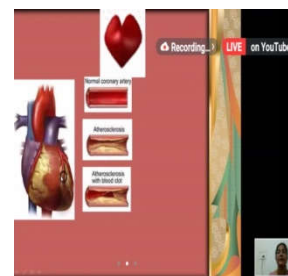

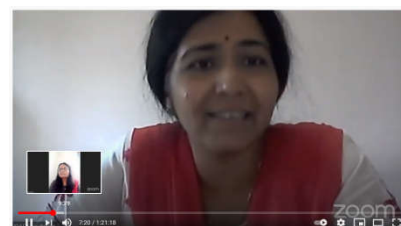

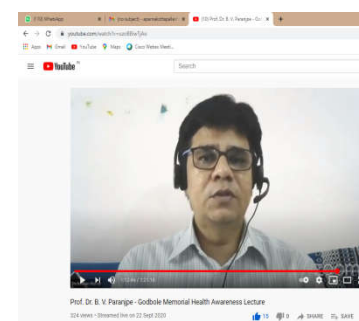

The workshop was inaugurated with the special presence of **Hon'ble Professor**



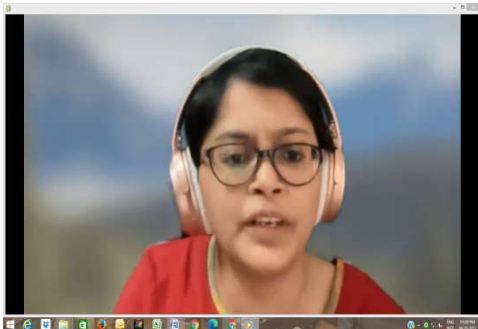
