

LAW LECTURE SERIES REPORT 2022-23

1. Virtual Lecture on Rights of Minorities under the Indian Constitution:

In order to celebrate **Minority Rights Day**, we organized an online lecture on “**Rights of Minorities under the Indian Constitution**” on **18th December 2022**. This lecture was delivered by **Dr. Nitesh D Chaudhari**, Principal, NTVS College of Law, Institute of Legal Education & Research, Nandurbar, Maharashtra. During lecture he has highlighted problems & concerns of minorities in India. He also covered various schemes available to minorities in India. He also clarified the doubts & questions raised by students.



2. Virtual Lecture to celebrate University Naam Vistar Day:

On **14th January 2023** on the eve of Marathwada University Naam Vistar Din as Dr. Babasaheb Ambedkar Marathwada University, Aurangabad we arranged a special online lecture on “**Dr. Babasaheb Ambedkar: a Legal Luminary**”. **Dr. Aparna Kottapalle**, IQAC coordinator of our college while delivering her lecture has cited many examples depicting legal expertise of Dr. B. R. Ambedkar. She made her session more interactive.

3. Lecture on Basic Structure under the Indian Constitution:

On **27th January 2023** we organized a special Lecture of **Dr. Sanjay Jain**, Professor of Law, National Law School of India University, Bengaluru on Basic Structure under the Indian Constitution. He has thrown light on how Judiciary evolved this concept of Basic Structure. He said Basic structure is always pregnant with new babies. He expressed his opinions on impact of this doctrine. Later on he made forum open for discussion & question & answers wherein he satisfied & answered all the queries of Students.

4. Lecture on Stages of Criminal Trial:

In order to provide practical knowledge, we organized a special lecture of **Adv. Nilesh Ghanekar**, a leading practitioner in Aurangabad on stages of **Criminal Trial**. This lecture was organized on **11th February 2023**. He explained the procedural aspects with practical examples involved at every stage. He narrated every stage from the lodging of FIR to Judgment in very simple & easy language. He focussed more on the evidence stage & has guided how to conduct chief & cross examination.



5. Dr. Babasaheb Ambedkar Lecture Series:



Every year we apply to our university for sponsoring Lecture Series. This Year University approved our request & sponsored **Ten Thousand Rupees (10,000/-)** to organize **Dr. Babasaheb Ambedkar Lecture Series**. We organized this Lecture Series on **11th March 2023**. This Lecture series was conducted in two Sessions. In First Session Chief Guest **Dr.R. K. Kshirsagar**, former Principal, Dr. Babasaheb Ambedkar Arts & Commerce College, Aurangabad delivered his talk

on **“Dr. Babasaheb Ambedkar & Land Reform Laws”**. He spoke on role of Dr. Babasaheb Ambedkar in making Land reforms through Constitutional Amendments. He also spoke on need of land reforms & its objectives. In Second Session Chief Guest **Adv.Sanjeev Deshpande**, Senoir Counsel, Bombay High Court spoke on **“Preamble of the Indian Constitution & Present Scenario”**. During interactive session, he focused on Basic Principles enshrines in the Preamble. He stated that Constitution of any Country is its autobiography. He appealed everyone to abide & obey every basic principle enshrined. He also explained the present state of affairs in the Country. He has explained how our framers used very specific terms in the Preamble & avoided ambiguity. **Mr. Abhay Jadhav**, coordinator introduced about the event & **Mr. Shrikishan Morey**, Vice Principal delivered Presidential address.



6. Lecture on Stages of Civil Suit:



In order to provide practical knowledge in Civil matters, we organized a special lecture of **Adv. Pramod Patni**, a leading practitioner in Aurangabad on **Stages of Civil Suit**. This lecture was organized on **08th April 2023**. He guided on stages of Civil Suit with practical application. During lecture, he also covered some provisions of Limitation Act & Evidence Act.
