'The Preamble and Its Significance: The Message and Practice' and on 'The Idea and dimensions of



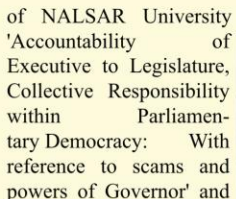

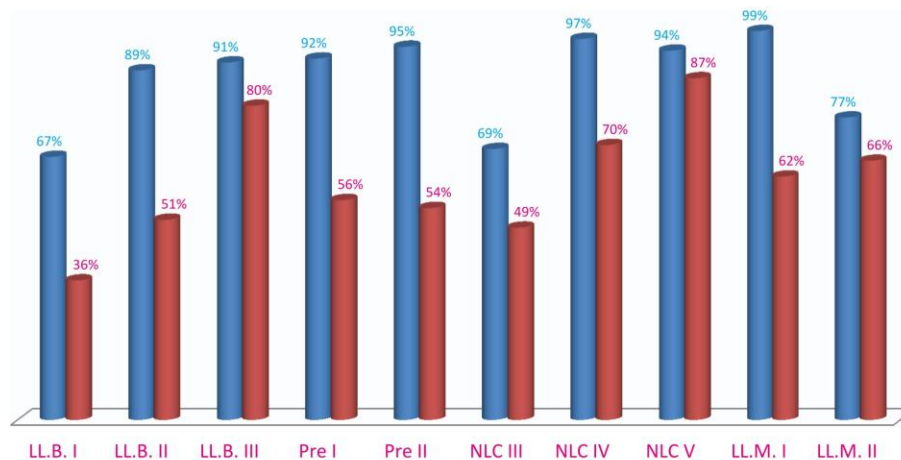
