

Report On XVII National Moot Court Competition

In the present academic year, institution has successfully organized the XVII National Moot Court Competition. For your kind perusal we have prepared the report on the XVII National Moot Court Competition as under.....

➤ Dates of the Competition:-

The XVII National Moot Court Competition was held on 11th & 12th February 2015. The said dates were already determined in a meeting of staff at the end of last academic year.

➤ Moot Court Problems or Moot Propositions:-

So far as Framing of Moot Court Problem or Moot Proposition is concerned, we adopt innovative changes from time to time. In this year, we had invited problems from teachers, advocates, students from all over the India. We received 9 Moot problems and had selected 2 problems for the competition by appointing a Selection committee consisting of Hon'ble Justice A.B.Naik, former Judge of High Court, Adv. U Makant Patil and Adv. Rajendra Deshmukh Management memers and Leading Practitioners of Bombay High Court.

Sending Invitations to Participate:-

The process of sending Invitations through email to participate in the said competition was started in the month of October 2016. We have send invitation through email around 2000 Law colleges and universities in India. We have sent the same thrice on different dates.

We have also sent the hard copies of Invitation to 300 Law colleges and universities in India in the first week of November 2016. We have appointed one student coordinator for sending invitations through email.

➤ ***Formation of Committees of Student Volunteers:-***

After sending Invitations we have circulated a notice in College to all the students who are interested to act as Volunteers in the said Competition. We received overwhelming response from the students as nearly 70 students shown their keen interest. But requirement was of only 30 students, hence we along with respected Principal Dr. C. M.
