From the Principal's Desk...


Welcome to our Vol. IV of News Letter for the year 2014-15.


National Seminar on

Reporting of Judicial and Legislative Proceedings by Media

Media is the most powerful sector in the world.



Media plays a vital role in the promotion, protection and realization of any rights. Today widely



proliferated print and electronic media is operating as the most effective watch dog of all democratic systems of governance world over. Growing volumes of law in tune with advancing technology accommodated the promotion of media laws too. In this regard a national seminar on "Reporting of Judicial and Legislative Proceedings by Media" was organized on 13th & 14th Sept. 2014 on this eve a book was also published which contained the innovative thoughts of the participants in conjunction with the seminar.

The seminar was inaugurated by the auspicious hands of Hon'ble Mr. Justice Kalyan Jyoti Sengupta, Chief Justice of Andhra Pradesh and Telangana High Court. Hon'ble Justice quoted various examples from his personal experience and advised the press not to go beyond 'Laxmanrekha' while reporting

judicial and legislative proceedings. Dr. Sudhir Gavhane, Head of Department, Mass Communication




and Journalism, Dr. Babasaheb Ambedkar Marathwada University, Aurangabad delivered keynote address on this occasion. He appealed media to focus on the positive news. President of the inaugural session Hon'ble Chairman of M. L. & G. E. Society Adv. Shri R. D. Deshpande highlighted the importance of the topic in the present day context. The seminar has been divided into five



technical sessions along with an inaugural and a valedictory session.

First technical session was conducted on the "Constitutional Foundations of Media Freedom". Keynote address was given by Dr. Mansing Parmar from Ahilyadevi Holkar Vishwa Vidyalaya, Indore






the college organizes National Moot Court Competition every year. College is proud to announce that this year it conducted XV National
