- 3. Each entry will consist of only 01 participant.
- 4. There is no entry fee for the contest.

# **PHASES OF THE COMPETITION:**

- Participants shall send the soft copies of PPT and Registration form on the following e- Mail ID:<u>mplcppt@gmail.com</u>
- 2. Same subject power point presentation which was submitted in the immediate preceding competition will not be accepted (*The list of PPT subject of last year is annexed herewith*).
- *3.* The contest has **TWO rounds:** 
  - a) The Screening Round
  - b) The Final Round
- 4. In the screening round the presentations will be sent to the panel which consist of experts from Social Science and Law. A total of fifteen presentations will be shortlisted for the Final Round.
- 5. Results along with marks secured in the Screening Round as well as Final Round will be communicated to all the participants through mail.
- 6. The Fifteen presentations that qualify for the final round would be intimated in advance of their qualifying for the final round.
- 7. The Final Round of the contest shall be held Online. The fifteen participants who have qualified for the final round will have to present their Power Point Presentations before a panel of judges.
- 8. Selected participants of final round of the competition shall appear for identity check (Online) before the beginning of final round of the competition.

### **PRESENTATIONS:**

- *1.* The presentations shall be compatible with Microsoft Office 2007.
- 2. It may have a maximum of 20 slides inclusive of participant's details.

#### **RULES FOR ONLINE COMPETITION:**

- 1. The Titles used by the participants must tell the topic
- 2. The final round will be live online presentation before panel of judges.
- *3.* The final round is within the time frame of 10 Min. online presentation and 05 Min. Question and Answer Session.
- 4. The competition will be held on WebEx Platform.

### **CRITERIA FOR ASSESSMENT:**

- *1*. In the **Screening Round** the power point presentations of the participants would be screened for **10 marks** each on
  - a) Content
  - b) Subject Analysis
  - c) Innovative Ideas, originality and creativity
  - d) Inclusion of Audio/ Video effects, exceptional use of power point skill and techniques
  - e) Conclusion
- 2. In the Final Round, The participants presentation would be judged for 10 marks each on
  - f) Speech Content
  - g) Body Language / Video / Audio / Innovations
  - h) Articulation and Conveyance of Thoughts
  - i) Handling of Technicalities with comfort
  - j) Time Management
- 3. In all the participants would be given scores out of a total of **100 marks**.
- 4. The participants will have to give an undertaking that their work is original. If it is found that the work is not original the entry may be cancelled. Students are advised to give proper references/ due credit to the author whether of a book/ internet source for any thought, idea or phrases and audio visual aid if used that may have been copied from such work.
- 5. The decision of the College authorities shall be final in case if any dispute arises.
- 6. The presentations once made shall be the property of M.P. Law College and must not have been submitted by the participant elsewhere earlier nor shall be submitted elsewhere at latter date.


