

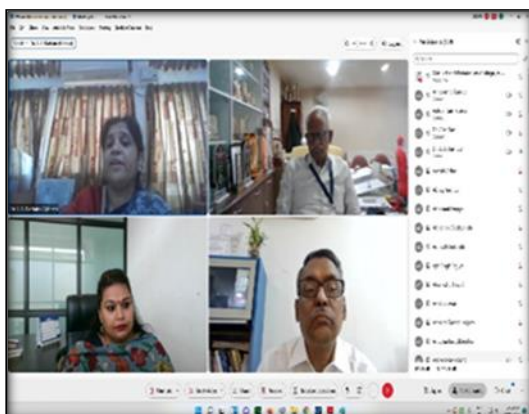

Report of the Workshop on Intellectual Property Enforcement

Manikchand Pahade Law College Aurangabad and DPIIT IPR CHAIR, Gujarat National Law University, Gandhinagar, Gujarat in collaboration with Cell for IPR Promotion and Management (CIPAM) organized a one-day online National Level Workshop on Intellectual Property Enforcement on 4th April 2022.



This IPR workshop was consisted of three sessions apart from inaugural. We started with the inauguration of the workshop for which Dr. Anama Samual, DPIIT-IPR Chair Professor, Gujarat National Law University (GNLU), Gujarat was the chief guests and Dr. C. M. Rao, Principal of Manikchand Pahade Law College,

Aurangabad was the president of the function. In the beginning of the programme, Dr. Shital S. Barhate, Coordinator of the workshop gave introduction about the College and Workshop to the participants, thereafter, Prof. Annama Sammual gave the introductory remark about the workshop and Dr. C. M. Rao, principal of the college inaugurated the workshop and gave the presidential address. 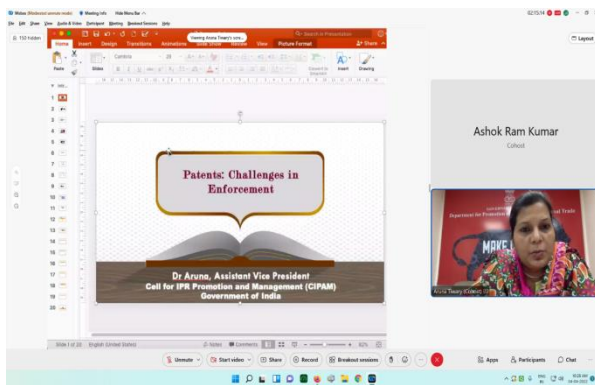


In this workshop, the first session was conducted on IP enforcement: Civil and Criminal Remedies from 9:15 a.m. to 10:15 a.m. wherein Mr Ashok Ram Kumar, founder and senior IPR attorney, WORDICT IP, was the resource person.



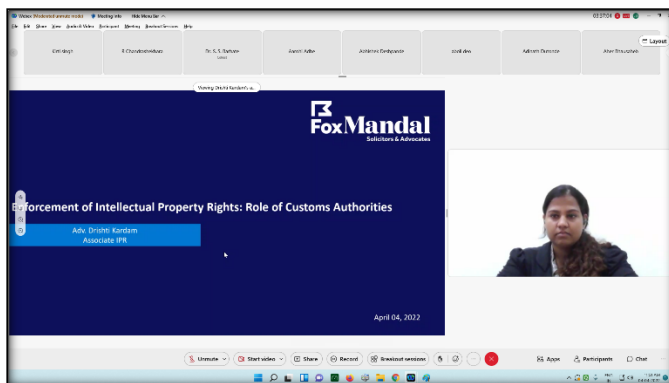
Mr. Kumar explained that any Intellectual Property has four pillars i.e. invention and innovation, Filing and prosecution, and Enforcement and Valuation.

Coming to civil remedies, the speaker highlighted the purpose of injunctive orders. He further explains that there are various judgments that explain where injunctions can be sought. While explaining the injunction orders he shared an example of a case that he handled which was of 'Paradise Biryani' in Hyderabad. At the end of the session, the speaker answered few questions from the participants, clearing up questions they had about the theme of the first session.



In the second session we had with us Dr. Aruna Tiwary, Assistant Vice President at Cell for IPR Promotion and Management, CIPAM. She delivered her discourse on "Challenges faced in enforcement of Patent rights".

In the third session Adv. Drishti Kardam Associate Attorney, Fox Mandal & Associates. Her



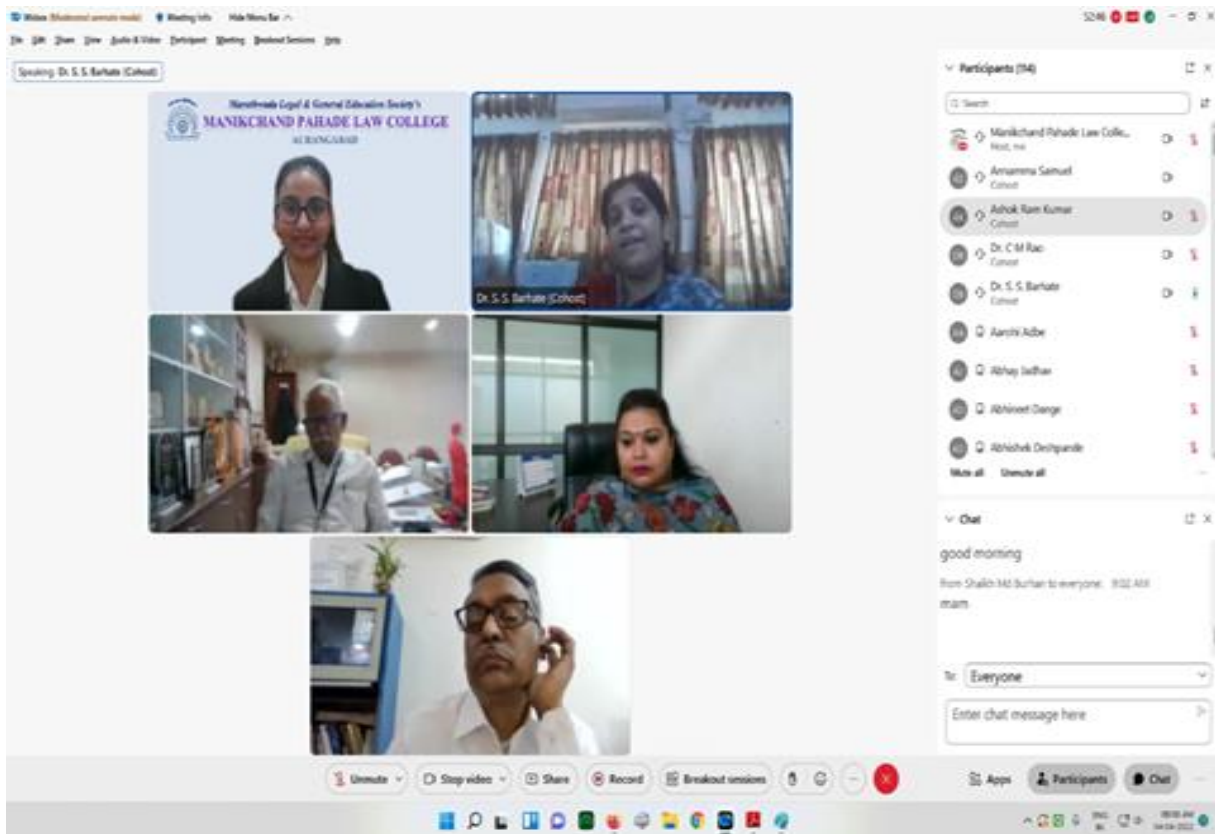
topic of discourse was "IP Enforcement: Role of Customs Authority". She discussed about the IP Enforcement- Role of Customs Authority. In her initial discourse she explained about Intellectual property rights & its types, Relevant laws for border protection of various Intellectual

Property Rights in India. Thereafter she dealt in detail about the role of customs authority in enforcement of Intellectual property Rights in India.

After the third session, Vote of thanks was done by Ms. Drishti Khurana Assistant Manager, CIPAM. The Workshop was anchored by Miss. Rashi Maknikar, student of NLC V year of the college.
