

Report of the National Level Online Seminar New Process of NAAC Accreditation and Assessment of Legal education Institutions in India

Sponsored by NAAC 5th and 6th August 2022

M L & G E Society's Manikchand Pahade Law College , Aurangabad had sent the proposal for the financial support to conduct A national Level Seminar on 'New Process of NAAC Accreditation and Assessment of Legal education Institutions in India' to the office of NAAC , the same was granted by them with the direction to conduct it online instead of physical mode. Accordingly the college had organised online seminar with the above mentioned theme during 5th and 6th August 2022.

Objectives of the Seminar:

Since the process of Accreditation and Assessment of educational Institutions by NAAC has begun we find tremendous positive change in quality improvement in the educational institutions throughout India. Since recent past the methodology of assessment was changed from physical mode to partially online mode with QLM and QNMs and third party evaluations considering the need to carryout changes for legal educational institutions the esteemed office of NAAC has brought new manual especially for legal education Institutions in the year 2021. Though the basic structure of assessment, criteria remain the same important changes are introduced through the new manuals which are certainly helpful for the law colleges and other legal educational institutions for getting assessed. Hence this Seminar was organised considering following aspects

- 1. There is a need of creating more awareness amongst legal education institution stakeholders about it and Hence, with the objective of creating awareness about this manual
- 2. Need of proper orientation about expected tasks to be undertaken by the institutions for further quality enhancement.

With the above mentioned objectives this seminar was divided into Following Subthemes which were discussed and deliberated in different sessions during these two days.

Inaugural Session

For the Inaugural session Hon'ble Prof. Vijay Kumar, Vice-Chancellor, NLIU, Bhopal




curricular and extracurricular activities of the college. She further explained the need of having dialog of management with the staff, faculty and students, apart from budgetary
