Workshop on Farmers Suicide: Causes and aftermath

As every year Research club of the college celebrates Human Rights day, this year Workshop on Farmers Suicide: Causes and aftermath on 10th December, 2015 was organized in ML&GE Society’s Tapadiya Natya Mandir. This year due to draught situation, no. of farmer suicide cases increased in

Maharashtra especially in Marathwada and Vidarbha region. Hence to create sensitivity about this problem in young minds, so as to initiate discussion on reasons and preventive measures this workshop was organized. The ML&GE Society was kind enough to provide seed money to conduct this event. Financial assistance of Rs. 10,000/- was received from Mr. Shantanu Deshpande, MD specialty polyforms (I), Pvt. Ltd. Aurangabad fund also was raised through the registration process

Total 186 people all over Maharashtra participated in this workshop. There was overwhelming response not only by the faculty and students from different colleges but social activists, and vigilant citizenry also participated. Students of research club also acted as volunteers, all the faculty was involved and instrumental in conducting sessions in this workshop.

In the beginning, before the inauguration of the workshop, students of the college performed skit on the theme of Farmers Suicide.

Inauguration: The Workshop was Inaugurated at the auspicious hands of Hon'ble Dr. Vijaykumar Fad, Div. Dy commissioner, Gen. Adm. Aurangabad and Hon'ble Adv. J.K. Wasadikar, Vice president of ML&GE Society presided over the inaugural function. Dr. C.M. Rao, Principal introduced the college activities and developments to the participants. In the introductory note Dr. Aparna Kottapalle, Coordinator of Research Club and Workshop communicated the object of the workshop and also intention to contribute fund to State for helping farmers families in distress. Dr. Fad in his inaugural speech expressed satisfaction for organizing workshop on this theme and urged participants to come forward to create awareness about government schemes and policies amongst farmers he expected people to support farmers and not to just show sympathy. During the session, Posters prepared by the students of research club on various subthemes were released at the auspicious hands of the dignitaries.

I session farmers suicide and legal aspects – In this session legal aspects policies were discussed by Adv Dinesh Sharma Nagpur whereas Shri Gunvant Patil, Social activist farmers Organization in his presentation expressed the problems of and hue and cry of farmers community, the need of fixing prices of farm produce so as to enhance the standard of living of farmers.

Session II Farmers Suicide and Preventive measures – During this session resource persons Adv. Vishnu Dhoble while addressing emphasized on how religion and State has exploited farmer since long, while dealing with the problem Dr. Arundhati Patil, from Manavlok- in her presentation she referred to her own research study on causes of farmers suicide and conditions of the family of farmers who committed suicide in Gevrai Dist. Beed .

Session III- Individual and Social responsibilities –

This session was divided in three sub themes. **Dr. Girdhar Patil**, Agricultural Expert was the resource person of this session while addressing he focused on how individuals and society must have sensitivity towards farmers and the entitlement of farmers to lead the life with dignity.

Prof.Dr. Jaidev Dole Dept. of Journalism and mass communication, Dr. BAMU addressed on role of media in prevention and redressal of farmers suicides

Smt. Sunita Tagare, CSR- Bajaj Aurangabad who was the resource person for the third sub theme and dealt with the issue of corporate social responsibility. As an illustration she referred to Bajaj company's contribution under CSR.

Thereafter before the valedictory, during tea break cultural event was organized wherein students of the college performed Maharashtra's folk dance.
