

Field Visits for Environmental Law

For LL.B. 3 years & LL.B. 5 years final year students field visit was organized under the Subject Environmental Law to S. B. College Unit of Maharashtra Pollution Control Board for observation of Air Pollution in Aurangabad City on 03/08/2018. Ms. Tiwari who works as Research Associate for Pollution Control Board guided students



on the issue of Air Pollution and its gravity in central city place. Students visited the plant, observed the equipments and machineries and further visited the lab where the pollution is actually monitored and calculated. The students later had an interactive session with Maharashtra Pollution Control Board Associates. For the

same course the second visit was organized at CEPT i.e. Central Effluent Treatment Plant, Waluj on dt. 6/9/2018. Mr. Suraj Gaikwad and other officers at plant explained the functioning and utility of the treatment plant. The students along with teacher visited all the plant sites and observed practically how the effluent treatment occurs.
