Report of Moot Court Activity 2017-18

XVIII National Moot Court Competition 2018

In this academic year our college has conducted XVIII National Moot Court Competition in February 2018.Report of the same is as follows:

Dates of the competition:

Every year we conduct this competition in two rounds i.e. preliminary and final. This year competition was held on 10th and 11th February 2018. The said dates were already determined in the meeting of the staff at the end of last academic year.

Moot Court problems:

Every year we invite teachers, advocates and students throughout India to frame moot court problem. This year we send invitation for framing moot court problem in the month of September to various Law colleges and Universities. This year we receive eight problems which were then sent to selection committee consisting of Hon'ble retired judge of High Court and leading practitioners in Aurangabad. Selection committee had selected two problem one for preliminary round and other for final round. Problem selected for preliminary round was set by Prof Prashant Desai, National Law School Bangalore and the problem selected for final round was set by Dr Ujwala Sakalkar, New Law College, Pune.

Sending invitations for participation:

Invitations to participate in this competition were sent by email and also by post. This invitation was consisting of letter from Principal, moot court rules, moot problems, registration form and travelling plan. The process of sending invitations through email was started in the month of October 2017.we send invitation by email to around 2000 law colleges and universities in India.We have also sent hard copies of the invitation to various law schools and colleges in India in the first week of November.

Registered and participated team:

Total nine teams have registered for this competition but one team expressed their inability to participate at last moment after payment of registration fees. The details of the participated teams is given below:

Formation of committees of student volunteers:

After receiving registration forms from the participants we started to form the committees of student volunteers for the said competition. We receive overwhelming response from the students but selected only fifteen students as per requirement. By conducting meeting these volunteers were shouldered with works in different committees such as Acomodation committee, Publicity committee, court hall management committee, discipline committee etc. the list of volunteers is enclosed along with this report.

Press conference:

Press conference was called on 8^{th} February 2018 with an objective to inform the people about this unique kind of activity carried out by our institution. In this press conference ----press reporters of different popular newspapers were present.

Accommodation:

Each participating team was consisting of three participants. Total participants were 27 but three teams were from Aurangabad hence not needed accommodation. For remaining participants we have provided accommodation for two days in Hotel Arts Executives which is very nearby to college campus.

One of the invitee Dr Ujwala Sakhalkar from New Law College Pune, who's problem is selected for final round of the competition was also provided with the accommodation in the same hotel.

Mode of the competition:

Like every year this year also competition was conducted in two rounds i.e. Preliminary and Final Round. In both these rounds one speaker from a team has to argue against the speaker of another team. It means it was not a competition as team but as an individual.

Preliminary round:

Preliminary round was conducted in college building. For this round two court halls were arranged and in each court hall four teams with unique code were distributed by drawing the lots. Each court hall was consisting of two judges to judge the performances of teams in preliminary round. The judges are the leading legal practitioners in Aurangabad. This round held on 10th February 2018. Names of the judges for preliminary round are as follows:
