In this academic year, our college has Planned XXI National Moot Court Competition in Feb.2021 but due to COVID 19 it was postponed and rescheduled in online mode in August 2021.Report of the same is as follows:

Dates of the competition:

Every year we conduct this competition in two rounds i.e. preliminary and final. This year competition was held on 28th & 29th August 2021.The said dates were already determined in the meeting of the staff.

Moot Court problems:

This year we received eight problems which were then sent to selection committee consisting of Hon'ble retired judge of High Court and leading practitioners in Aurangabad. Selection committee had selected two problems for preliminary and final round which were drafted by Mr.Adit Ved, Nagpur and Ms.Anjana Haridas, Faculty of Law, KMCT Law College, Kerala rpectively.

Mode of the competition:
